1. Introduction

Standards are becoming more and more important with the digital and green transformation. However, Standards do not appear on their own – they have to be proposed, written, negotiated, agreed and rewritten to keep them up to date.

Small Business Standards (SBS), the European non-profit association representing small and medium-sized enterprises (SME) in European and international standardisation was established in 2013. Its objectives are to represent the interests of European SMEs in the standardisation process, to raise their awareness about standardisation, facilitate the uptake of standards among SMEs and to motivate them to engage in the standardisation process.

SMEs are a key part of the European economy; they create growth, employment and new jobs. In the EU's private sector alone, SMEs account for two-thirds of all jobs. The European economy is undergoing unprecedented transformations. The European Commission has put the green and digital transitions on top of the political agenda as the two trends that will shape Europe and its future. Standards are important enablers of this digital and green transformation. Moreover, the success in achieving these EU objectives requires the involvement of SMEs.

SMEs often hesitate to take part in the standardisation process and their participation is low relative to their importance within the economy. This is to a big extent due to the lack of resources and knowledge about the standardisation process. This is also why SMEs tend to rely more than large companies on business associations to represent their interest in standardisation. The role of SME associations is key to bridge the gap between SMEs and standardisation and represent the collective interests of SMEs.

Therefore, SBS wanted to have a better insight into the current knowledge of SME associations on standardisation and their relationship with the National Standards Bodies (NSBs). This concerns the involvement of SME associations in the work of the NSBs, the support offered to SMEs/SME associations by the National Standard Bodies and the national governments to get further involved in standardisation as well as how SME associations interact with their respective NSBs.

In view of this, SBS launched a questionnaire in the second half of 2022 addressed to SME associations to have a better insight into the current knowledge of SME associations about the national standardisation system and their relationship with the National Standards Bodies (NSBs).

Although the results cannot be described as fully representative, they give an indication of the challenges and difficulties faced and the recommendations of this report can be used as basis for establishing recommendations that can support the further involvement of SMEs and SME associations in standardisation at the national level.

The outcome of the study will be used in SBS' contacts with the NSBs and to feed into the implementation of the [EU Standardisation Strategy](#)¹ published early in 2022 by the European Commission. The strategy foresees the launch of a peer review between Member States and

national standards bodies to identify where SME participation at the national level could be improved. The results of the survey and the recommendations of the report also aim at contributing to this process.

2. Methodology

The questionnaire was drafted by SBS in English and translated into French, German, Italian and Spanish (Annex 1). The survey was published in October 2022 and was open for a month. The questionnaire was simple and quick to fill in - so that it was not too time-consuming for SME associations to participate. In the introduction, the context of the survey was explained, how the results would be used and the importance of the participation in the collection of information to get a good overview on the situation in the different countries.

Besides disseminating the survey among the members of SBS and SMEUnited, the association of crafts and SMEs in Europe member of SBS, the survey was also distributed through the Enterprise Europe Network (EEN) and the CEN-CENELEC SME Working Group. The survey was published on the SBS website and promoted on the different social media channels of SBS and SMEUnited.


Once the contributions had been collected, SBS analysed the information received. The survey was targeting horizontal and sectoral SME associations at national and regional level, however SBS received quite a few answers from other entities. The evaluation mainly focused on the information received from the SME associations and to a certain extent also from SMEs. The answers from other entities (bigger companies, certification bodies etc) were not included in the analysis since this was not the main target audience for this survey.

Based on the analysis of the answers and the comparison of the results of the questionnaire, SBS summarised the information received during the survey. The conclusions reached also contain a series of recommendations addressed to the NSBs as well as Member states, which will also be useful for the several and different stakeholders interested.

3. Overview of responses

In total, 121 answers were submitted of which 4 were doubles. This means that 117 organisations answered the survey.

The answers came from 13 different countries: Austria, Belgium, Bulgaria, Croatia, Czech Republic, France, Germany, Italy, Luxemburg, Netherlands, Poland, Spain, UK.



Although the survey was targeting horizontal and sectoral SME associations at the national and regional levels, SBS received quite a few answers from other entities. This is an overview of the different entities which responded to the survey:

This report will however focus on the results of the survey among the SME associations and small and medium-sized enterprises (SME), which were the main target of the survey.

* The questionnaire, addressed to SME associations, offered different answers concerning the type of association (National horizontal SME organisation, National sectoral SME organisation, regional horizontal SME organisation, regional sectoral SME organisation, Other, please specify). Some entities, which were not an SME organisation, identified themselves wrongly as National Standards Bodies (NSB).

The majority of the answers came from national horizontal and national sectoral associations and to a lesser extent from regional horizontal and regional sectoral associations.


The answers from SME associations according to type showed the following distribution:

National horizontal associations: 16

Regional horizontal associations: 2


National sectoral associations: 20

The answers from SME associations according to country showed the following distribution.

Austria (1), Belgium (1), Bulgaria (2), Croatia (6), Czech Republic (4), France (2), Germany (5), Italy (4), Luxemburg (1), Netherlands (1), Poland (13), Spain (2), UK (2).



3.1. Relation with National Standards Bodies

Out of the 44 SME associations answering the survey 85% (38) stated that they were in contact with their National Standardisation Bodies. This included receiving general information, like newsletters or press releases, participation in a specific SME working group / stakeholder group or regular bi-lateral meetings. Of those associations which were in contact:

- 84% (32) stated that they participate in a group of stakeholders or specific Technical Committees;
- 55% (21) receive general information;
- 34% (13) participate in a specific SME WG;
- 13% (5) have regular bi-lateral meetings.

Those which were not in contact with the NSBs stated that this was because:

- they did not know the NSBs 33.3% (2)
- standardisation was of no interest for them 16.6% (1) or,
- they lacked financial resources 16.6% (1) and involvement requires payment to the NSBs.

Two of them did not give a reason.

Out of the 38 associations in contact with the NSBs, 84% (32) were involved in standardisation work in Technical Committees either through a staff member, an expert linked to the association, a member association or an SME which is a member of the association.

From the 6 associations, which were in contact with the NSB but not involved in a Technical Committee, 83% (5) stated they did not know how to get involved and 66.6% (4) answered that they lack financial and / or human resources. 33.3% (2) of the associations mentioned

other reasons that they encountered obstacles from the side of the NSB. Multiple answers were possible.

3.2. Special Conditions for SMEs

In the survey, SBS asked the SME associations about specific efforts and special conditions offered by the NSBs to SMEs or SME associations to promote their participation and access to the standardisation work.

The following examples of special conditions were indicated in the questionnaire: dedicated part on the website of the NSB, specific training for SMEs / SME associations, free access or reduced fees for SMEs to participate in Technical Committees and working groups, special rates for SMEs for purchasing standards, free access to draft standards, free access to mandatory and harmonised standards, abstracts of standards freely available on the NSB website, translation of draft standards into the national language or translation of the final standards into the national language.


The responses of the SME associations were very diverse. While some mentioned a concrete measure, others only indicated the existence without giving more information. 38% of the SME associations indicate they do not know about any special conditions, and some did not answer the question at all. Some answers from the same country were also contradictory, one saying 'no measures exist' while another SME association listed a concrete measure.

Moreover, the fact that some measures were not mentioned in relation to some countries does not mean they are not in place. For example, while it was not mentioned that Austrian Standards provides abstracts/summaries of standards for free, we are aware that this is actually the case. This shows that there is a lack of knowledge on existing measures and possibly not enough promotion for these measures towards SMEs and SME associations. Finding relevant information on these measures through the main page of the National Standards Bodies is also often not very straight forward.

3.3 Online Platform of the NSBs

The question on the existence of an online platform, where draft standards under enquiry can be consulted and comments can be submitted, was only answered by 50% (22) of the associations. While for 7 countries a concrete website was mentioned, in 2 cases was not the online platform where standards under enquiry could be consulted and commented, but rather the general website of the standards institute or a website with general information for SMEs. 3 respondents only indicated the existence, 1 indicated it did not know and in 2 cases it was answered that no website exists. For one country there was no answer to the question. Only the platforms put in place by the standards bodies of Belgium, Germany and the Netherlands were rightly identified. It has to be pointed out though that in some cases these platforms are not always kept up to date.

Below there is a summary of the answers received. This should not be taken as an indication of whether an online platform to consult standards under enquiry exists since, in some cases, although the platform was not identified by the respondents, a platform does exist (e.g. Spain, Austria). This shows that the existing platforms that allow for the public commenting of draft standards are not known to the SME associations and that therefore more should be done to promote their existence and the possibility for SMEs and SME associations to comment on draft standards through these platforms.

3.4. Support by the National Governments

The questionnaire also asked whether the national or regional government offered financial or other support to foster the participation of SMEs and / or SME associations in the standardisation process at the national, European or international level. The responses of the SME associations were very diverse. While some mentioned a concrete measure, other only indicated the existence without giving more information, some indicated they do not know, and some did not answer the question at all. For some countries contradictory answers were given. Below there is a summary of the answers received. It can be concluded that in general there does not seem to be specific government programmes or incentives to support SME and SME association participation in standardisation or at least these are not widely known.


3.5. Topics discussed with NSBs

The SME associations were asked if they had ever discussed special conditions for SMEs and SME associations with their NSBs.

15 associations stated that they did not discuss with their NSB and 13 said that they did not know about any discussion. A horizontal association from Bulgaria answered that this discussion was done by the sectoral associations.

The associations which indicated that they discussed with their NSB mentioned the following topics of discussion.

The results of the survey showed that the most discussed issues have to do with reduced fees or free access for SMEs and SME associations to technical committees and working groups followed by the availability of special rates for SMEs to purchase standards and the availability of training. The question of access to draft standards and the translation into the national language are also important points for discussion. Both could boost the participation of SMEs in the national standardisation work. To improve the uptake of standards the access to draft standards, mandatory and harmonised standards for free or with a special rate for SMEs and SME associations is also discussed by the SME associations with the NSBs. In 4 countries targeted information and specific training to inform SMEs and SME associations about the

existing possibilities to get involved in standardisation had been discussed. In one country, there is a demand for a special SME part on the NSBs' website,

4. Recommendations for an Improvement of the National Standardisation System by SME associations

Some of the SME associations made concrete proposals to increase and improve the engagements of SMEs and SME associations at the national level.

They asked for more marketing and visibility of NSB, more information for entrepreneurs on standardisation, sector-specific information and information on the benefits that businesses can get from standardisation. One way to do this would be to collect stories and case studies of SMEs involved in standardisation (what is their motivation / ambition and what are the results) and promote these stories among SMEs.

Requests for training for SMEs were also made. One proposal was to create a specific training programme on standard in collaboration with specialised training companies in several modules: a general module, valid for all sectors, and specific modules for each sector. This could be accompanied by a communication and awareness-raising campaign.

Besides the general training for SMEs and SME associations on standardisation, specific training for SME experts about the work in TCs and WGs was suggested since it is important that SME experts have a good understanding of the process used in standardisation and when and how to have an influence on this process. One of the respondents asked for a revision of the standardisation process to increase simplicity in the management of the committees and to the texts for drafters and readers. It was pointed out that often form prevailed over making the content of standards more understandable and straight forward. Another respondent said it would be useful to provide a way, with a proactive role of NSBs, to identify in advance the Committees and Working Groups of strategic importance for specific sectors and SMEs.

Concerning the concrete involvement of SMEs, it was suggested that the NSBs should offer support for the representative SME associations (easier access, financial conditions, communication, involvement, training of experts etc.), because most of the SMEs would only get involved in standardisation via their SME associations. In this context, the free access or reduced fees for SMEs and SME associations to participate in Technical Committees (TCs) and working groups (WGs) was also mentioned. One comment asked to better consider the SME perspective in working groups and a more balanced representation of SME associations taking into account their representativeness.

Financial support for the participation and the work of SME experts was another request, which was also addressed to the national governments. One suggestion was that the SME association could pay a lump sum to the NSB to gain access for SME experts. Another

association suggested simplifying the access by giving SME associations the possibility to finance the experts' participation, a model similar to the SBS one.

Better access to draft standards for SME associations and their member companies or even free access to draft standards was mentioned. With regard of purchasing costs for SMEs for all types of standards and especially harmonised and mandatory standards a reduction or free access was proposed. This seems to be already in place in some countries. Costs, although not the only one, are still a barrier for small businesses.

Finally, the translation of draft, especially harmonised standards during the standardisation process, and final standards into the national language was mentioned as an important factor for SMEs.

5. Evaluations of Questionnaires Answered by Companies

5.1. General remarks

Companies were not the intended target of the survey, however, SBS received 33 questionnaires filled in by companies of which 29 were SMEs and 4 were larger companies. All 33 answers were taken into consideration comparing the answers from SMEs with those of the larger companies.

The answers came from 7 countries in total with a high percentage from Poland. However, even if not taking into consideration the answers coming from Polish companies the results of the replies from companies would be very similar.

Since the survey was not indented to be answered by companies this option did not appear in the questionnaire. Therefore, many companies identified themselves falsely as 'SME association'. The incorrect classification of the responding entity needed to be corrected manually.


The companies did not always answer all questions and in some cases multiple answers were possible. In a large number of cases, the answer was 'I do not know'. In several cases, the answers coming from the same country were contradictory, which is an indication that companies were not well informed about existing sources of information, support measures etc.

The evaluation of the questionnaires answered by companies might allow some hypothesis which would however have to be verified in a separate survey.

5.2. Overview of company responses

As mentioned above, 29 answers were received from SMEs in 7 countries and 4 from larger companies. The majority of answers came from companies based in Poland. The distribution of SMEs by country can be found below:

Since it is not known how the questionnaire was distributed it might be that especially companies were targeted which are already somehow involved in standardisation.

When asked if they were in contact with the NSB, 62% of the SMEs (23 out of 29) answered yes while all the 4 large companies answered yes. 13.7% of SMEs (4) answered they were not in contact with the NSB and 6.8% (2) said they did not know.

According to their answers:

- 51% (15) SMEs participate in a stakeholder group or a specific Technical Committee

- 39% (7) receive general information, newsletter etc.
- 5% (1 SME) also participated in a specific SME working group of the NSB.

The 13.7% (4) of SMEs which were not in contact with the NSB stated that they did not have the human and/or financial resources 6.8% (2) to get involved, they did not know them 3.4% (1) or standardisation is of no interest to them 3.4% (1).

Of the large companies, 75% (3) participated in a stakeholder group or a specific Technical Committee and one participates in a specific SME working group. This large company indicated the participation in the SME WG through an SME (most likely a subsidiary or smaller entity controlled by the big company). This highlights the importance of ensuring that NSBs also consider a proper definition of small and medium-size businesses when creating and developing specific SME groups or initiatives.

Concerning their involvement in a Technical Committee the 23 SMEs, which were in contact with the NSB, indicated the following (multiple answers possible):

- 15 SMEs through a staff member,
- 6 through an association,
- 4 through another SME which is member of an association,
- 1 through an expert linked to them.

20.6% (6) SMEs answered that they were not involved, and 6.8% (2) SMEs did not know. As their reasons for not participating in a Technical Committee, they stated not to know the NSB (2), they did not know how to get involved (1) and they did not have the financial and/or human resources. The other SMEs did not give a reason why they were not involved in a Technical Committee.

While SMEs were involved in a Technical Committee, none of them is member of the management structures of the NSB or participates in the NSB decision-making on standardisation policy. One of the larger companies is said to be involved in the NSB decision-making on standardisation policy.

Asked about specific efforts of the NSB or special conditions offered to SMEs, only one SME knew about a dedicated part on the website, one about specific training offered for SMEs and one about the translation of the final standards in the national language, while 8 SMEs answered that there were no specific efforts or offers from the NSB (27%) and 14 of the 29 SMEs (48%) stated that they did not know. One large company knew about special rates for SMEs for purchasing standards and one about abstracts freely available on the website.

When asked about the existence of an online platform where the draft standards under enquiry can be consulted and commented upon 62% (18) SMEs answered 'yes', 3.4% (1) answered 'no' and 10.3% (3) said they did not know and 13.7% (4) did not answer the question. Of the large companies 50% of them knew about the online platform, while the 50% did not know. However, even if the companies claimed to know about a platform a majority did not indicate a web address or did only mention the general address of the NSB.

The answer to the question concerning any support by the national or regional government revealed that the SMEs as well as the large companies either claimed that there were no support measures or they did not know about them. Those entities confirming the existence did not specify which ones.

Even though many of the companies were involved in a Technical Committee they seemed to have only limited information about the services of the NSB or available support for SMEs. This can be also deducted from some answers in which companies answered they participate in a Technical Committee but stated on the other hand that they have no contact to the NSB.

5.3. Suggestions for Improvement made by SMEs

Five SMEs made suggestions for better involvement of SMEs and SME associations in the national standardisation process. None of the large companies made any suggestions.

A suggestion was made concerning the awareness level and the visibility of the NSBs. It was proposed to raise the presence in the media and at industry exhibitions. It was suggested to improve communication, especially about offers for SMEs to get engaged in standardisation. The need to ensure the diversity of the stakeholders involved was also mentioned.

In this context, more transparency concerning cooperation between the different stakeholders was mentioned. It would be appreciated to make the access simpler and to have a special contact person for SMEs in the NSBs. Apparently, the fact that on the CEN CENELEC website there is a list of contacts at the national level (<https://www.cencenelec.eu/get-involved/small-and-medium-enterprises-smes/smcs-and-standards/local-support-for-smes/>) does not seem to be broadly known at national level.

Another suggestion made was specific training for SMEs and SME associations. However, from the experience of the past, it is often difficult to raise sufficient interest in training offers.

Several suggestions concerned financial support for the participation in standardisation, either for the participation in Technical Committees as such, for travel expenses or for the hours dedicated by SME experts to the development of standards. In an answer coming from the UK, it was mentioned that financial support had existed but no longer did. It was highlighted that offering the possibility to participate virtually in meetings of the Technical Committees and working groups facilitates SMEs' attendance.

Financial support for SMEs could also be offered through special rates for purchasing standards. In case of changes to a standard, it was suggested to publish the content as a single document, not as a basic standard and changes (amendment 1) A1, A2, A12 etc. and enabling the purchase of the publication with the introduced change on preferential terms for the person who bought the basic standard.

The question of translation of draft standards as well as final standards also seemed to be an important point for SMEs.

6. Conclusions

Together with craft companies, SMEs make up 99,8 % of all business in the EU. Yet SMEs do not always have a strong enough voice in ensuring their needs are considered in the standardisation process. If SMEs are not sufficiently represented in discussing, writing and updating standards, their needs might not be taken into account. The final standard might even place unnecessary or inappropriate requirements on them.

SMEs, much more often than bigger companies, use their SME associations to get informed on relevant topics, also in relation to standardisation, since often they do not have enough resources and knowledge to get involved directly. SME associations have an important role to play in bridging the gap between SMEs and standardisation. Therefore, it was important to look at the relationship of SME associations with their National Standards Bodies to see if the relationship exists, is sufficiently close, and if there is room for improvement. The questionnaire also tried to gather information on the demands addressed to the NSBs coming from the SME associations and which of those demands are realistic and could be implemented. It turned out that although they were not targeted by the survey, the small companies raised similar issues as mentioned by the SME associations.

The results of the survey indicate that the improvement of the relationship between NSBs, SME association and SMEs needs to be tackled at all levels (awareness, participation in the development process, access to standards...).

1. Lack of information and transparency

There appears to be a lack of visibility concerning the NSBs, transparency as well as information on how SMEs can get involved. While 85% of the SME association stated that they were in contact with their NSBs only 34% participate in a specific SME working group and only 13% have regular bi-lateral meetings.

Of those SME organisations, which were not in contact with the NSBs and gave a reason, 50% stated that this was because they did not know the NSBs, 25% said that they lacked financial resources, and the involvement requires payment to the NSBs and 25% replied that standardisation was of no interest for them.

38% of the SME associations were not aware of any specific measures to support participation and information for SMEs. 62% of SME associations were aware and could mention some measures to support SME involvement in standardisation. However, it was visible that there is a significant difference in knowledge and information among the SME associations. In addition, in some countries, more measures exist but they are not known and have not been indicated by any of the associations. Only 11% of SME associations and 3% of SMEs mentioned that the NSB offers a dedicated part for SMEs on its website.

On the question about an online platform, where draft standards under enquiry can be consulted and commented, for only 6 of the 13 countries (46%) a website was mentioned. However, only the Belgian, German and Dutch platforms were correctly identified. For 25%

(3) countries it was mentioned that the website exists but without giving a link, for 16% (2) countries there was no indication and for another 16% (2) countries the given answer was 'no' while the website exists. This shows clearly that online platforms to provide comments on standards under enquiry are not widely known. Unfortunately, in some cases, they are not fully up to date. The means for SMEs and SME associations to get involved, including this one should be more widely promoted.

The visibility could be improved through a more proactive approach towards SME associations by the NSBs, more visibility and openness of the NSBs and also a closer cooperation with representative SME associations. There is a need for NSBs to be more proactive towards SME associations which could raise awareness of their members on the existence of the NSBs, their structure and their way of working as well as the benefits of standardisation for SMEs. NSBs as well as SME associations need to inform SMEs much more about the benefits of standards but also about the benefit of getting involved in the standardisation work through commenting or participation in Technical Committees.

Some of the SME associations made concrete proposals to increase and improve the engagements of SMEs and SME associations at national level. They asked for more marketing and visibility of NSB for example at trade fairs and promotion of the SME contact in the NSB. Suggested was also to offer more information for entrepreneurs on standardisation, sector-specific information and information on the benefits that businesses can get from standardisation. One way to do this would be to collect stories and case studies of SMEs involved in standardisation (what is their motivation / ambition and what are the results) and promote these stories among SMEs.

2. Training and Understanding of how to get involved

The need for specific training for SMEs was raised. One proposal was to create a specific training programme on standards in collaboration with specialised training companies in several modules: a general module, valid for all sectors, and specific modules for each sector. This could be accompanied by a communication and awareness-raising campaign.

Besides the general training for SMEs and SME associations on standardisation, specific training for SME experts about the work in TCs and WGs was suggested since it is important that SME experts have a good understanding of the process used in standardisation and when and how to have an influence on this process.

The enhanced cooperation between NSBs and SME associations also plays an important role concerning training for SMEs, SME associations and SME experts involved in Technical Committees and working groups. SME associations of 6 countries out of 13 (46%) stated that the NSBs offer specific training for SMEs / SME associations. In 4 of these 6 countries this question has been discussed with the NSB.

On one side there is a demand from the SME side, on the other side the information about existing training opportunities is lacking. In addition, it seems to be difficult to motivate representatives of SME associations and SMEs to participate in training courses. However,

research clearly shows that using standards can substantially increase an SME's turnover and contribute to increased productivity and GDP for a country.

3. Specific Support Measures for SMEs

Concerning the concrete involvement of SMEs, it was suggested that the NSBs should offer support for the representative SME associations (easier access, special financial conditions, etc.) because most of the SMEs would only get involved in standardisation via their SME associations. In this context, free access or reduced fees for SMEs and SME associations to participate in Technical Committees (TCs) and working groups (WGs) were demanded.

Financial support for the participation and the work of SME experts was another request, which was also addressed to the national governments. One suggestion was that an SME association could pay a lumpsum to the NSB to gain access for its SME experts. Another association suggested enabling the access by supplying the SME associations with the means to finance the experts' participation, a model similar to the SBS one.

Although financial measures by the NSBs, for example in the form of free and reduced fees, are favourable they are not the only solution. Support schemes of the EU Member States could do more. According to the information provided by SME associations, support schemes exist in France and Germany. This survey did not look in detail at whether the existing support schemes are successful. Another survey might look deeper into this topic to see if there are more EU Members States with specific support schemes and how widely known, SME friendly and successful they are.

However, emphasizing only the financial aspects as the reason not to participate in standardisation seem to be too narrowly viewed. In countries where participation for free or at reduced prices is available, the participation of SMEs is still low. Therefore, all other barriers also need to be looked at.

With regard to purchasing costs for SMEs for all types of standards, especially harmonised and mandatory standards, a reduction or free access was proposed. To improve the uptake of standards by SMEs preferential tariffs for buying standards were often requested because of the limited financial resources of SMEs. This seems to be already in place in some countries.

4. Further suggestions

Since SMEs have also limited human resources, a stronger involvement of the SME associations in the standardisation work would be beneficial. This could for example be achieved if the NSBs would offer special conditions to the SME associations and focus on building the capacity and understanding of SME associations staff concerning standardisation.

One SME association asked specifically to better consider the SME perspective in working groups and a more balanced representation of SME associations taking into account their representativeness. Another respondent said it would be useful to provide for a way, with a proactive role of NSBs, to identify in advance the Committees and Working Groups of strategic importance for specific sectors and SMEs.

There was also a request for a revision of the standardisation process to make it more SME-friendly, to simplify the language of the texts for drafters and readers and to increase simplicity in the management of the committees. It was pointed out that often form prevailed over making the content of standards more understandable and straight forward.

Finally, the translation of draft standards, especially harmonised standards, during the standardisation process, and of final standards into the national language seemed to be another important factor for SMEs and SME associations.

The survey has shown that it is important that NSBs pay specific attention to including SMEs in their work, enter into a dialogue with the representative SME associations and offer the right conditions for increased inclusion of SMEs and SME association in the standardisation work. From the 44 SME associations, only 20% replied to participate in an NSB management committee and 20% were involved in the NSB decision-making on standardisation policy while none of the SMEs was engaged in those bodies.

As mentioned in the European Standardisation Strategy, more can be done at national level to improve access to standardisation development and standards themselves. Only if all stakeholders work together and enhance their cooperation at the different levels a better representation of SMEs in the National Standards Bodies can be achieved.
